## RULES AND REGULATIONS

### GRAVE DECORATIONS

1. The Superintendent must authorize and plant at lot owners expense all permanent trees, shrubs, evergreens and perennials that may be requested.
2. The Superintendent is instructed to remove dead and damaged plants and faded artificial flowers at any time and to cut and trim plants and shrubs as he deems necessary.
3. One above ground arrangement per grave and one flower bed per lot is permitted.
4. No fence, curbing or railing shall be put around any lot.
5. No tomb shall be erected upon any lot.
6. Artificial arrangements attached to Monuments, candles, balloons and statues are not allowed.
7. Summer decorations must be removed by October 15<sup>th</sup> and Winter decorations must be removed by April 15<sup>th</sup>.
8. All proposed memorials and monuments must be approved in advance by the Superintendent.
9. The following varieties of plants are approved for In-ground Planting on Individual Lots.
  1. Taxus (Yews)
  2. Alberta Spruce

### CONDUCT OF PERSONS WITHIN THE CEMETERY

1. The Cemetery grounds will be open from 7:00 A.M. to sunset.
2. The Cemetery shall in no way be held liable for any injuries sustained by anyone in the Cemetery.
3. All persons are prohibited from any disrespectful use of the Cemetery grounds.
4. All persons are prohibited from gathering flowers, either wild or cultivated, breaking or cutting trees, shrubbery or plants, or defacing or otherwise damaging monuments or other structures.
5. Automobiles shall not exceed a speed of 15 miles per hour when driven through the grounds. Motorcycles, snowmobiles, go-carts and other mechanized vehicles are not allowed.
6. Dogs shall not be allowed on the Cemetery grounds.
7. No signs or notices or advertisements of any kind shall be allowed in the Cemetery unless placed by the Cemetery agents or employees.
8. The Superintendent or, in his absence, his representative, is hereby empowered to enforce all rules and regulations, and shall have supervision and control of all persons within the Cemetery, including the conduct of funerals, traffic and employees.

### MONUMENTS AND MARKERS

All work done in Green River Cemetery is done under the Rules approved by the Board of Trustees and the supervision of the Superintendent.

No Monument or Marker shall be erected in Green River Cemetery until the material, style and inscription have been approved by the Superintendent.
